

Minutes of the Louisiana State Board of Embalmers and Funeral Directors

On Wednesday, November 20, 2024, the Louisiana State Board of Embalmers and Funeral Directors ("LSBEFD") conducted a regularly scheduled in-person meeting at the board office located at The Executive Towers 3500 N. Causeway Boulevard Suite 1232 Metairie, Louisiana 70002 in accordance with La. R.S. 37:831, *et seq* and other appliable law.

1. Roll Call / Opening Remarks / Pledge of Allegiance

3. Inspector's Report

R. DeMale Bowden, Jr., Inspector, presented the Inspector's Report to the Board. Discussion ensued.

Board Members & Executive Director Michel:

My inspector's report for this November meeting is as follows:

INSPECTIONS

Inspections have been in the districts of B and C and date from October 10, 2024, to November 15, 2024. **54** inspections have been done during this period, which consisted of inspecting **47** funeral establishments and **7** crematories, while **ONE** new funeral establishment has been licensed/opened and **ONE** ownership change with **SIX** funeral establishment inspection have been performed.

Issues cited during those inspections during the dates previously mentioned are as follows:

FUNERAL ESTABLISHMENTS

- The current 2024 funeral establishment license is not being posted in the funeral establishment.
- A casket priced on the selection room floor WAS NOT on the casket price list.
- Preparation Room
- The conditions of the preparation room at the time of the inspection had to be addressed.
- The ventilation fan was not working properly at the time of the inspection.

Embalming Log The embalming log is in another room other than the embalming room.

The date the embalming procedure took place is missing on lines for certain cases.

The time the embalming procedure took place- began & ended is missing on lines for certain cases.

The embalmer's license number is not recorded on lines for certain cases.

It's my request that - EMBALMERS, PLEASE MAKE SURE YOU ARE COMPLETELY FILLING OUT THE EMBAMLING LOG AFTER EVERY EMBALMING.

INSPECTOR OBSERVATIONS/COMMENTS

As the 2025 renewal season has started, funeral establishments and crematory authorities are advised to make sure you have your accurate year's establishment license posted in your funeral establishment and/or crematory authority. Chapter 11 Funeral Establishments Section 1107 Inspections A says, "*each funeral establishment shall be subject to inspection*." If attempts are made to inspect a funeral establishment or crematory authority and they are unsuccessful, the board will be notified of these unsuccessful inspection attempts. The board may then take further action, which could include scheduling additional inspection attempts or investigating the reasons for the failure of the inspection.

Funeral establishments, please pay close attention to P&E requests (pick-up/embalming) from out-of-state/out-ofthe-country firms that you have never worked with before. Firms should ensure they are dealing with a licensed establishment or a legal next of kin regarding ship-out matters. We have been notified that there are individuals making calls saying they represent a licensed establishment and/or is licensed in another state/country requesting services and upon verification, they are not licensed in the state they claim to be a licensed in. If these individuals or establishments are not verified properly, it could lead to individuals coming into the state conducting services here without a licensee present and the illegal transport of human remains out of the state of Louisiana into other states and countries which border us without them having the proper documentation.

Inspector Bowden responded no and explained the process of what happens when an establishment has had one violation and what happens when that same firm has a 2nd or 3rd subsequent offense/violation that is the same.

Dixon, presiding and Ms. Debose continued presenting the Complaint Review Committee Report. Discussion ensued and including upcoming board meeting and hearing dates.

Board Member Maurice Southall made a motion, which was seconded by Board Member Juan Joseph to accept the Complaint Review Committee's report. The motion passed unanimously.

President Board Member Terry Luneau returned to the meeting and resumed his role as presiding officer.
